TPS4810-Q1 Evaluation Module for Smart High-Side Driver



Description

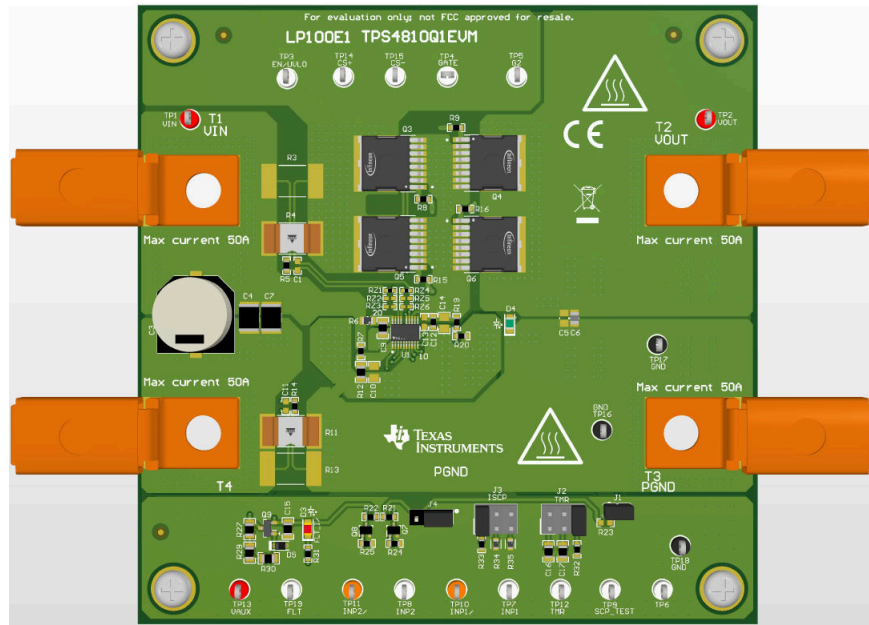
The TPS4810Q1EVM allows reference circuit evaluation of TI's TPS4810-Q1 smart high-side driver. The TPS4810-Q1 is a 3-V to 80-V smart high-side controller and has two strong 2-A gate drivers with separate control inputs (INP1, INP2) to drive back to back MOSFETs in common source configuration. The TPS4810-Q1 provides adjustable short circuit protection with configurable auto-retry and latch-off fault behavior.

1 Evaluation Module Overview

1.1 Introduction

TPS1210-Q1 device can also be evaluated on this EVM by replacing the TPS48100QDGXRQ1 (U1) with TPS12100QDGXRQ1 and connecting EN/UVLO (TP3) to VAUX (TP13).

This user's guide describes the TPS4810-Q1 evaluation module (EVM). This guide provides configuration information, test setup details and contains the EVM schematics, bill of materials, assembly drawings, and top and bottom board layouts.

1.3 Specification

- 24-V to 54-V (typ) operation
 - While testing for input voltage greater than 54-V, remove input 54-V TVS or use an appropriate TVS
- Current sensing options:
 - Low-side and high-side using external sense resistor (Selectable using CS_SEL pin)
 - MOSFET VDS

1.4 Device Information

The TPS4810x-Q1 family is a 100-V low IQ smart high side driver with protection and diagnostics. With wide operating voltage range of 3 V–80 V, the device is an excellent choice for 12-V, 24-V and 48-V system designs. The device can withstand and protect the loads from negative supply voltages down to –65 V. The device has two strong 2-A (src/sink) gate drivers with separate control inputs (INP1, INP2) to drive back to back MOSFETs in common source configuration. Strong GATE driving enables power switching using parallel MOSFETs in high current system designs.

The device provides adjustable short circuit protection. Auto-retry and latch-off fault behavior can be configured. By using CS+ and CS- pins, current sensing can be done either by an external sense resistor or by MOSFET VDS sensing. High side or low side current sense resistor configuration is possible by using CS_SEL pin input. The device also features diagnosis of the internal short circuit comparator using external control on SCP_TEST input.

2 Hardware

2.1 Overview

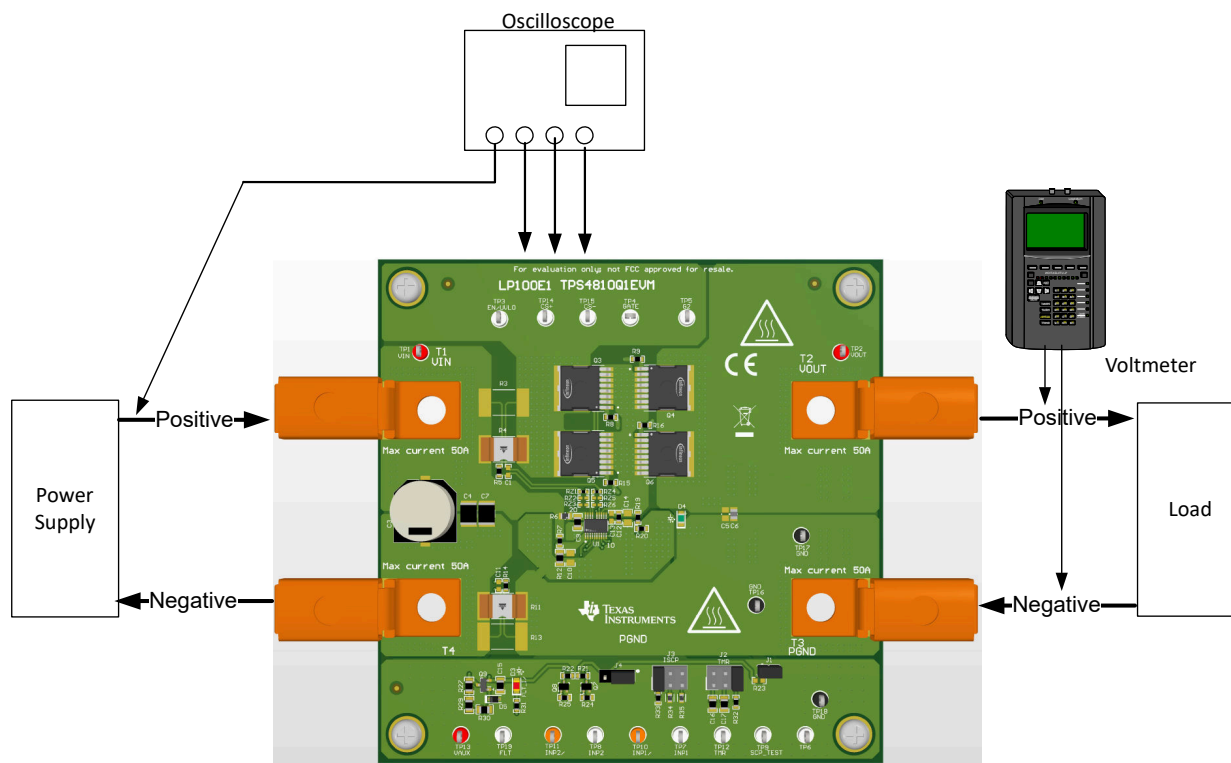


Figure 3-1. TPS4810Q1EVM Setup with Test Equipment

The TPS4810Q1EVM evaluation board enables evaluation of TPS48100-Q1 driver. The input power is applied between connectors T1 and T4 while T2 and T3 provide an output connection to the load. Refer to the schematic in [Figure 4-1](#) and EVM test setup in [Figure 3-1](#).

D3 provides the fault indication output for under-voltage fault, charge pump UVLO, short-circuit fault and during SCP comparator diagnosis.

2.2.2 Test Equipment and Setup

2.2.2.1 Power Supplies

One adjustable power supply with 0-V to 60V- output and 0-A to 50-A output current limit.

2.2.2.2 Meters

One DMM minimum needed.

2.2.2.3 Oscilloscope

A DPO2024 or equivalent, three 10 times voltage probes, and a DC current probe.

2.2.2.4 Loads

One resistive load or equivalent that can tolerate up to 50-A DC load at 60 V and capable of the output short.

3 Implementation Results

3.1 Test Setup and Procedures

Make sure the evaluation board has default jumper settings as shown in [Table 3-1](#).

Follow the below instructions before starting any test and repeat again before moving to next test.

- Set the power supply output (VIN) to zero volts.
- Turn ON the power supply and set the power supply output (VIN) to 48 V, current limit = 50 A.
- Turn OFF the power supply.
- Set the jumper setting on EVM to default position as shown in [Table 3-1](#).

3.1.1 Power-up with EN Control

Use the following instructions to verify the power up profile of TPS48100-Q1.

1. Connect the EN/UVLO pin (TP3) to ground.
2. Enable the EN/UVLO to HIGH to verify the startup profile of BST, GATE and SRC.

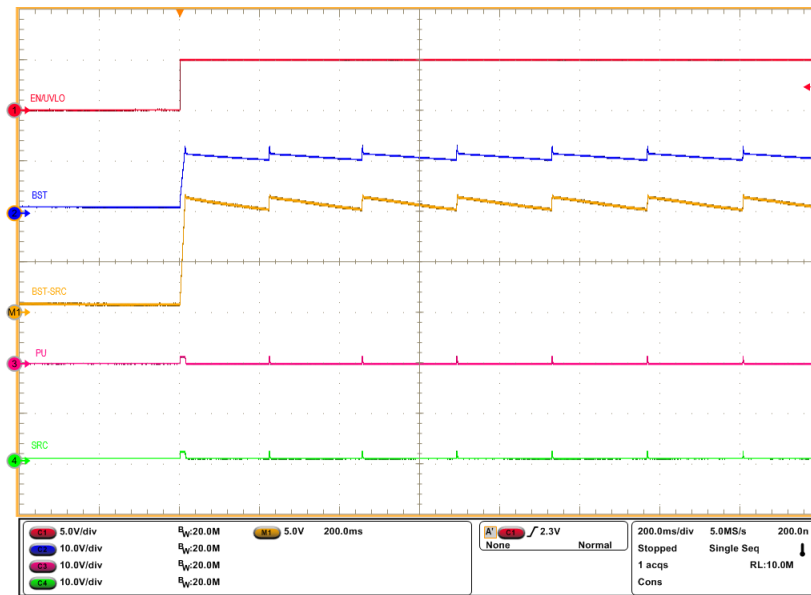


Figure 3-2. Start-Up Profile of Bootstrap Voltage with INP1=INP2 = GND, CBST = 470 nF

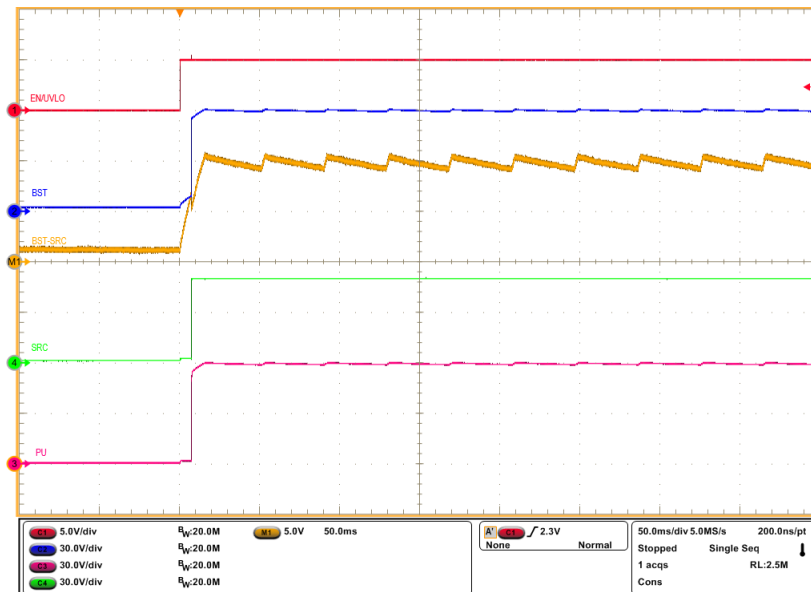


Figure 3-3. Start-Up Profile with INP1=INP2 = HIGH, CBST = 470 nF

3.1.2 Overload and Short Circuit Protection Test

Use the following instructions to perform over current test on the TPS4810Q1EVM:

1. Turn ON the power supply and set the power supply output VIN = 48 V, current limit = 50 A.
2. Set the Short Circuit Protection (SCP) threshold at 30 A by installing jumper J3 in 3-4 position and install jumper J2 in 1-2 position to set 1-ms delay.
3. Enable the control inputs (INP1 and INP2).
4. Now, load the output to 25 A with electronic load and apply a step of 10 A to observe the overload behavior of TPS4810Q-Q1.
5. Disconnect the load.
6. To perform short-circuit test, uninstall J2 to set shortest SCP delay.
7. Perform output short to capture the short-circuit behavior of TPS4810Q-Q1.

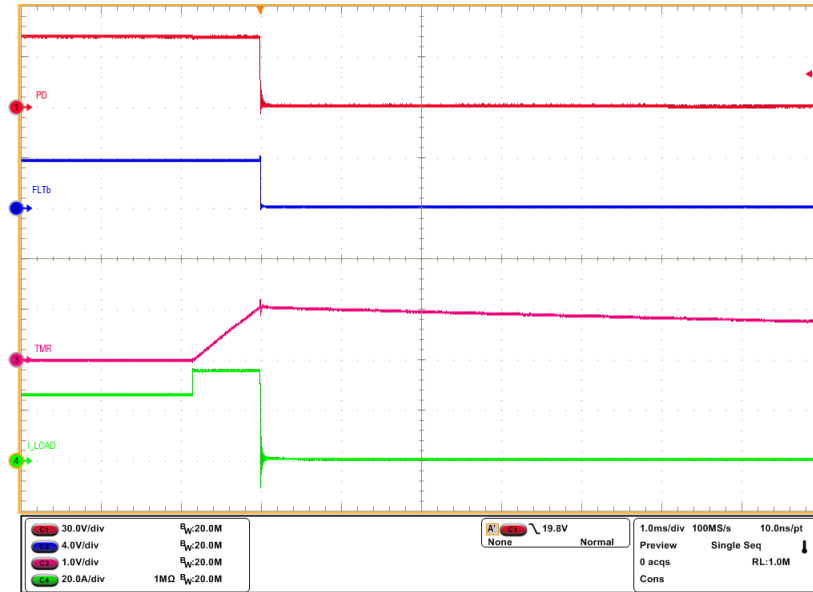


Figure 3-4. Overcurrent Response of TPS4810Q1EVM for 25-A to 35-A Load Step

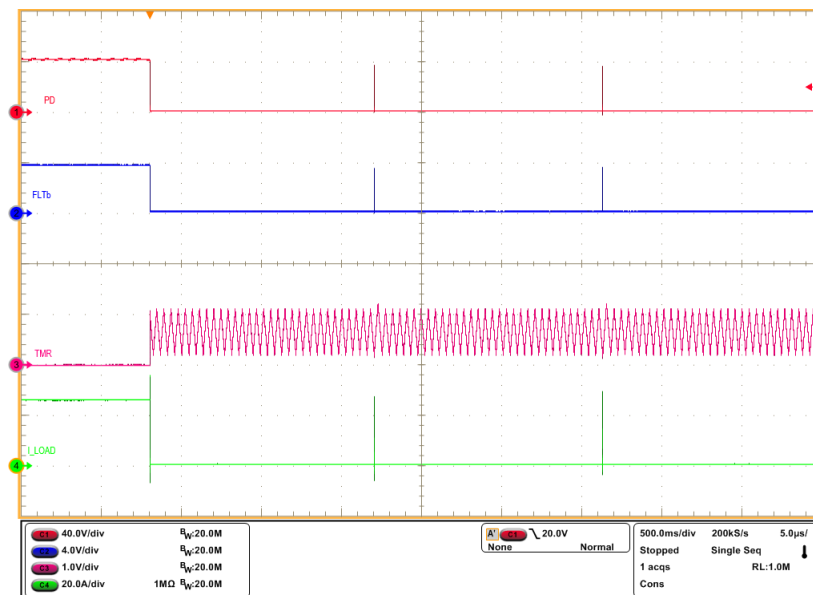


Figure 3-5. Auto-Retry Response of TPS4810Q-Q1 for an Overcurrent Fault

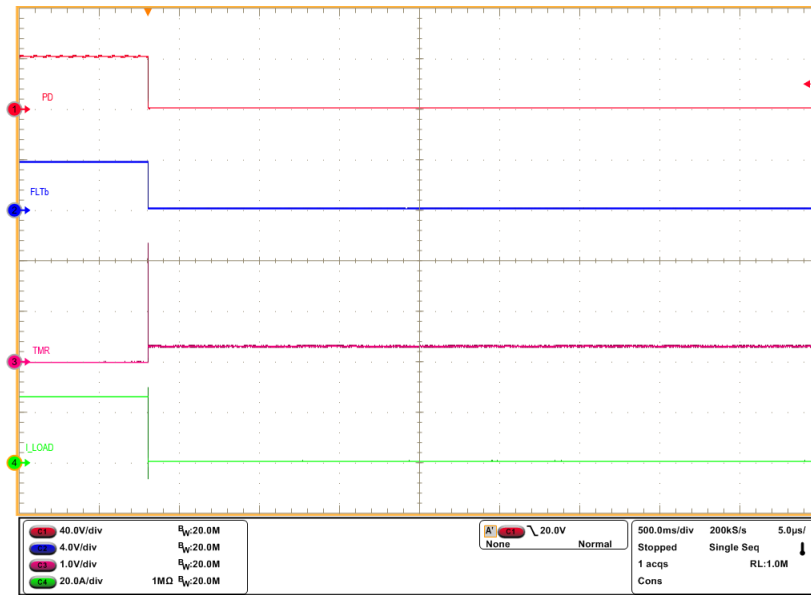


Figure 3-6. Latch-off Response of TPS4810-Q1 for an Overcurrent Fault

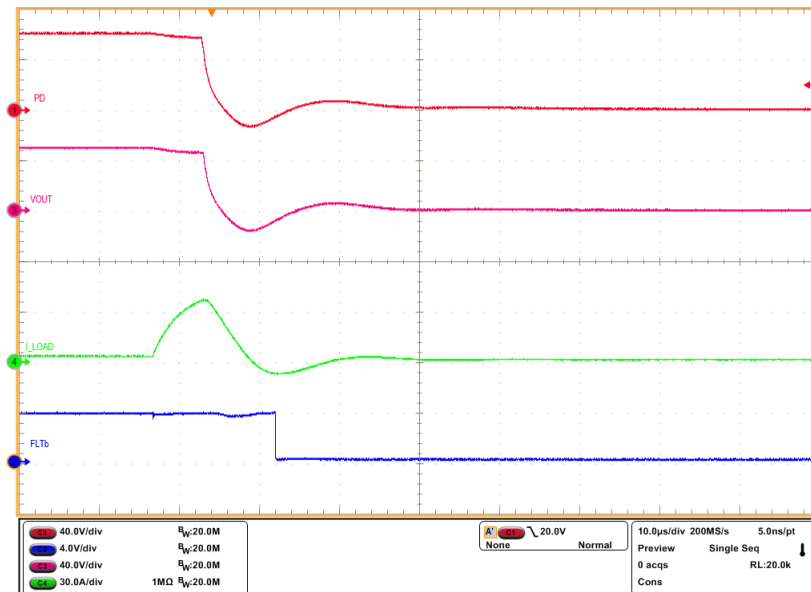


Figure 3-7. Output Short-Circuit Response of TPS4810-Q1

3.1.3 Short-Circuit Protection Diagnosis Test

Use the following instructions to perform the short circuit protection diagnosis test

1. Set the input supply voltage V_{IN} to 48 V and current limit of 10 A.
2. Enable the power supply.
3. Now, toggle the SCP_TEST (TP9) and observe the response of G1PU/PD and FLTb pins during short circuit comparator (SCP) diagnosis.

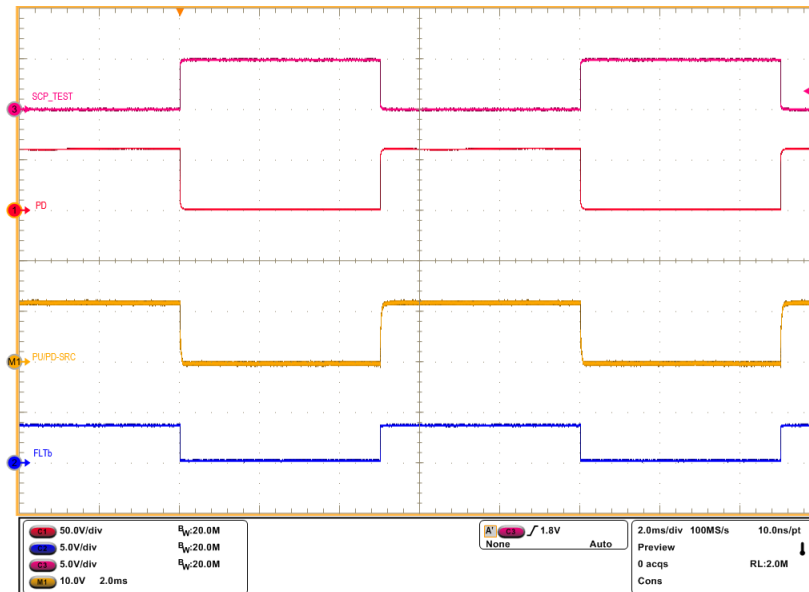


Figure 3-8. SCP_TEST Response of TPS48100-Q1

Figure 3-8 shows the SCP_TEST response of TPS48100-Q1 device.

3.1.4 Input Reverse Polarity Test

Use the following instructions to test the input reverse polarity protection:

1. Set the jumper setting on EVM to default position as shown in [Table 3-1](#).
2. Set the input supply voltage VIN to 60 V and current limit of 10 A.
3. Connect the power supply positive to T4 and power supply negative to T1. The power supply is now connected in reverse polarity at the input of TPS48100-Q1.
4. Enable the power supply.
5. Observe the waveform at VOUT (TP2) with an oscilloscope.

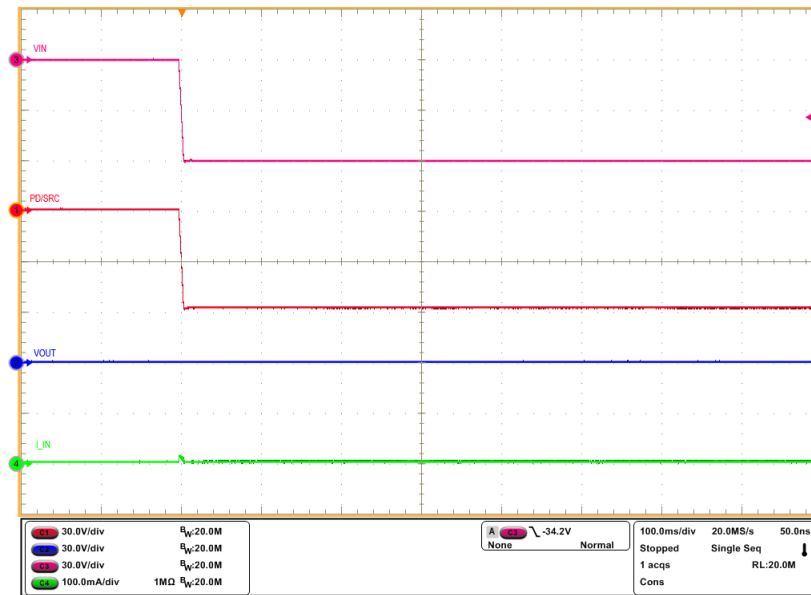


Figure 3-9. Input Reverse Polarity Protection of TPS48100-Q1 Device

Figure 3-9 shows input reverse polarity protection of TPS48100-Q1 on TPS4810Q1EVM Evaluation Board.

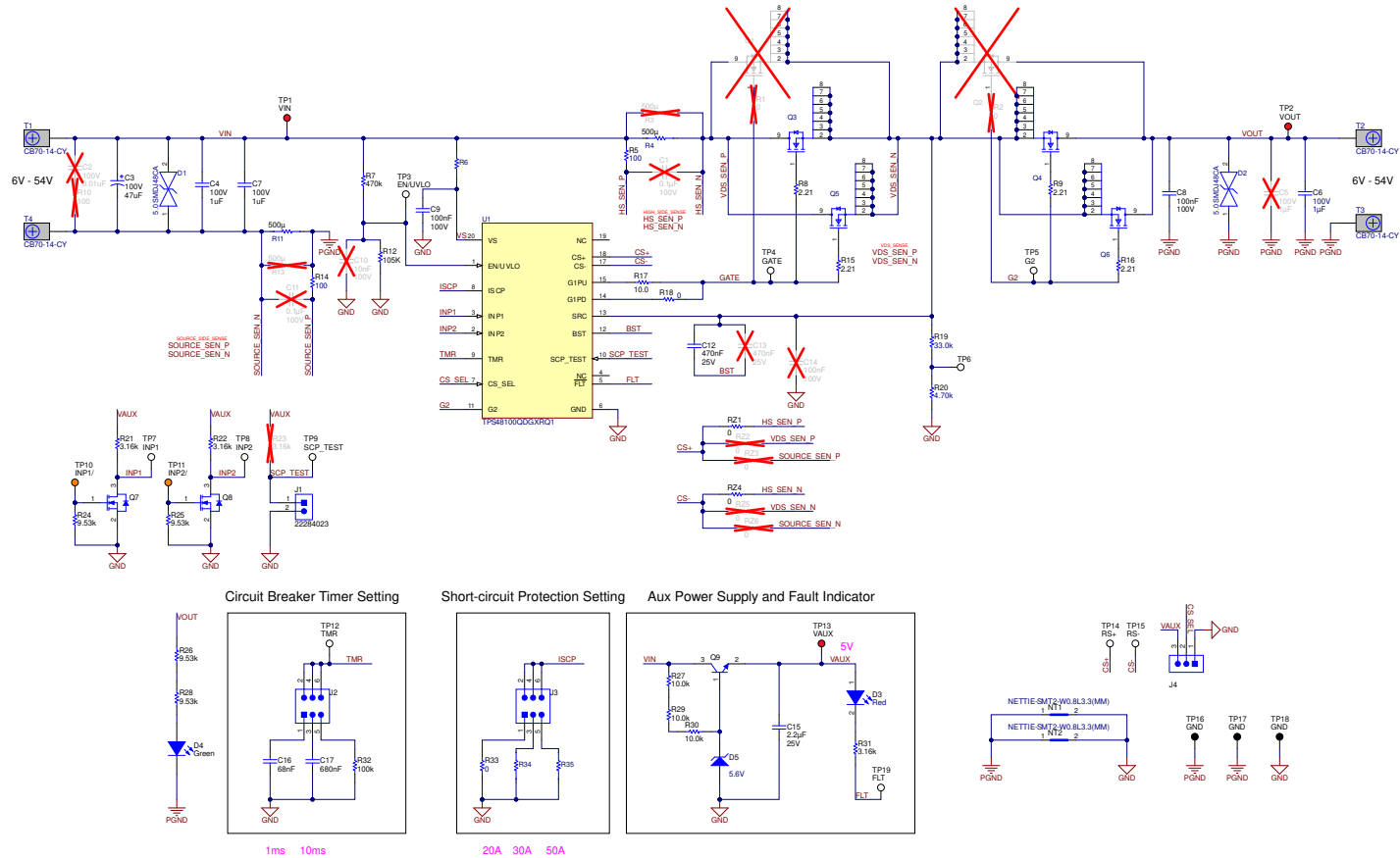


Figure 4-1. TPS4810Q1EVM: Evaluation Module Schematic

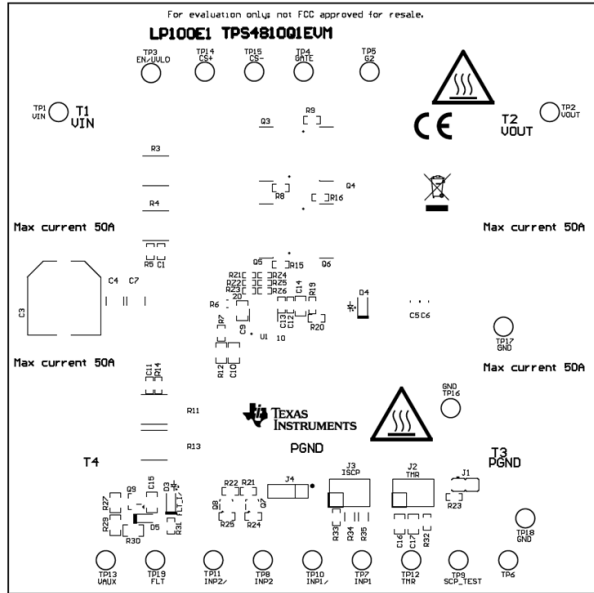


Figure 4-2. TPS4810Q1EVM Board Top Overlay

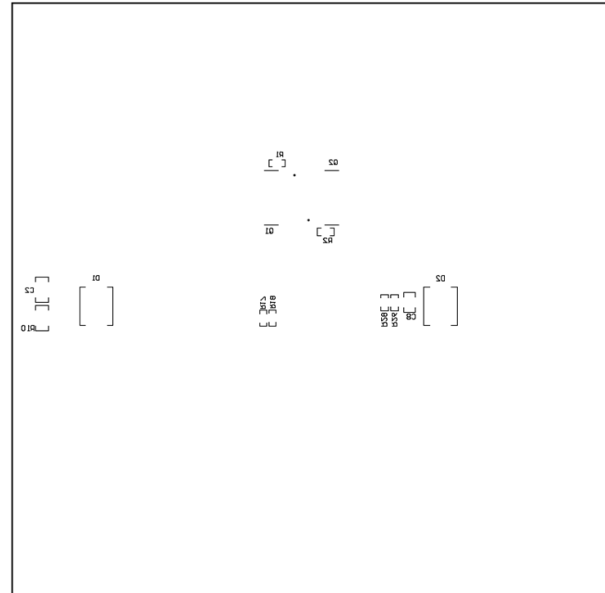


Figure 4-3. TPS4810Q1EVM Board Bottom Overlay

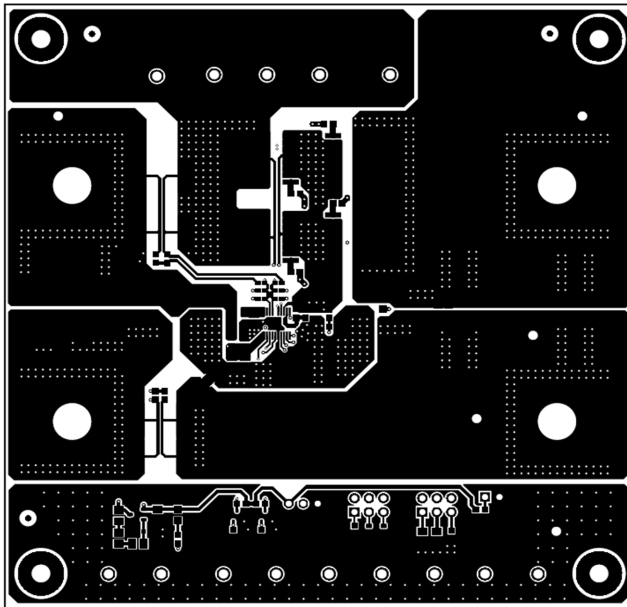


Figure 4-4. TPS4810Q1EVM Board Top Layer

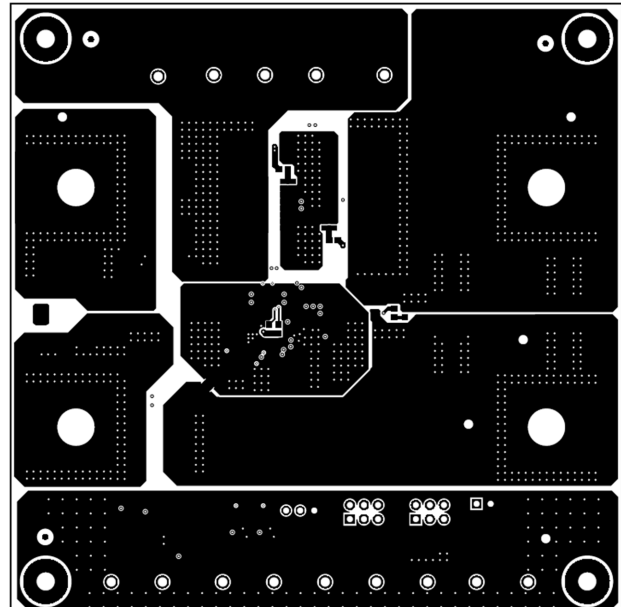


Figure 4-5. TPS4810Q1EVM Board Bottom Layer

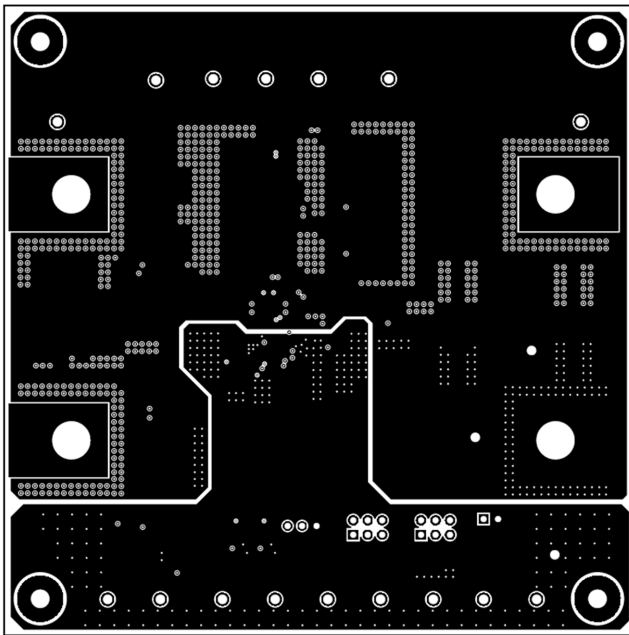


Figure 4-6. TPS4810Q1EVM Board Inner Signal Layer

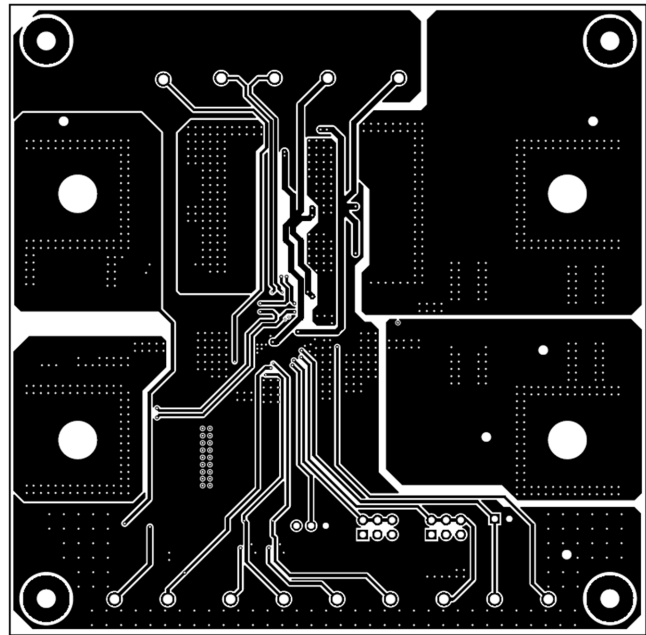


Figure 4-7. TPS4810Q1EVM Board Inner Routing Layer

FCC Interference Statement for Class B EVM devices

3.3.2 *Notice for Users of EVMs Considered "Radio Frequency Products" in Japan:* EVMs entering Japan may not be certified by TI as conforming to Technical Regulations of Radio Law of Japan.
