
3 Description




Figure 4-1. DBZ Package, 3-Pin SOT-23 (Top View)

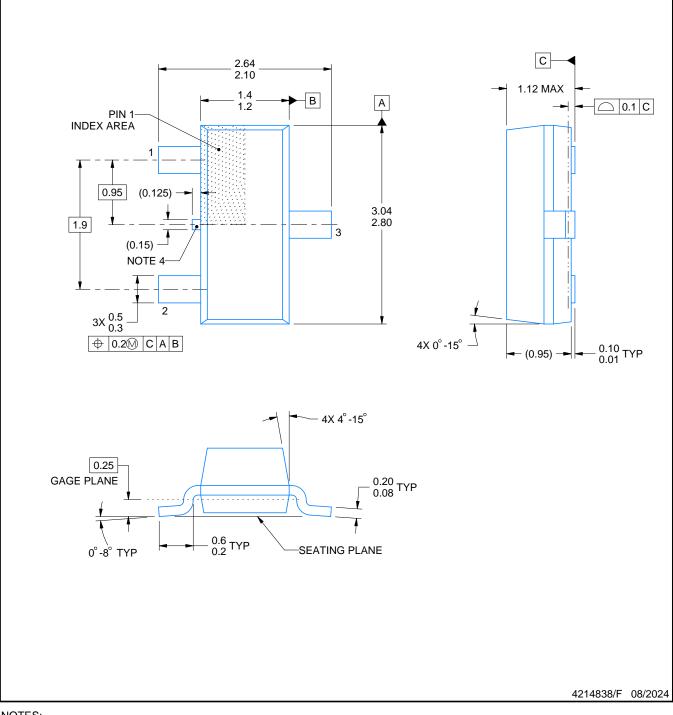

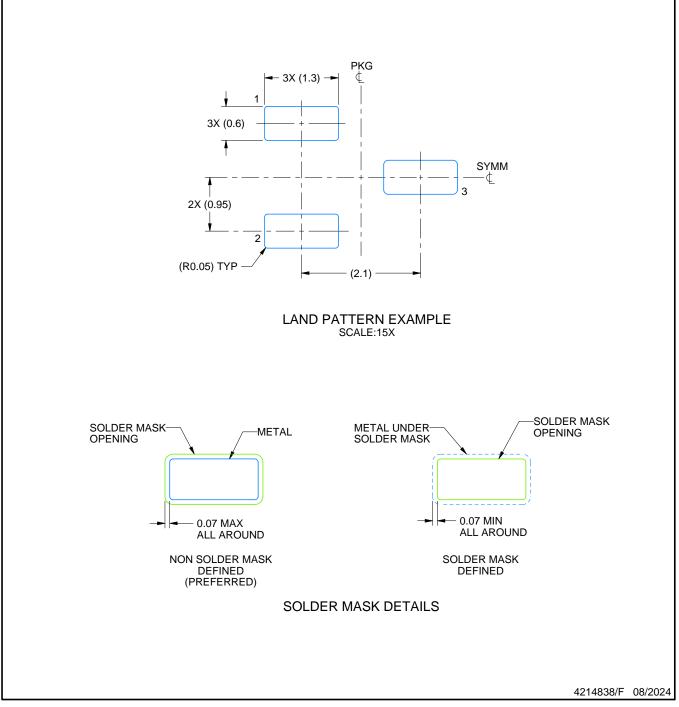


