

The SN74LVC1G3208 device is a single 3-input positive OR-AND gate. It performs the Boolean function $Y = (A + B) \bullet C$ in positive logic.

By tying one input to GND or V_{CC} , the SN74LVC1G3208 device offers two more functions. When C is tied to V_{CC}, this device performs as a 2input OR gate (Y = A + B). When A is tied to GND, the device works as a 2-input AND gate ($Y = B \bullet C$). This device also works as a 2-input AND gate when B is tied to GND ($Y = A \bullet C$).

NanoStar[™] and NanoFree[™] package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using I_{off} . The I_{off} circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.






Figure 1. 2-Input AND Gate





Figure 2. 2-Input OR Gate




Figure 3. $Y = (A + B) \bullet C$




